Old Business

Road Repairs. The Board received a response from the Ingham County Road Department regarding a request to address our issues with the recent road repairs. The following is their response:

As an update on the paving issues on Hadden Hall in last year's resurfacing project ponding on the approach at Eiffert Road, and premature cracking the crack repair / thin overlay section between Groombridge and Glendurgan streets, ICRD has met with the paving contractor—Rieth-Riley, and the following repairs will be done:

On the approach at Eiffert Road, which was and is very flat, Rieth-Riley will mill a match joint across the approach and along the front of the curb radii, and ICRD as part of our plans to do maintenance paving and chip-sealing on Eiffert Road this summer, will pave

Eiffert Road across and back into the Hadden Hall approach to raise the elevation of Eiffert Road enough to provide better water run-off on the approach. This work will probably be done in July and August.

Rieth Riley will re-heat, repair/close, and re-roll the cracks coinciding with the crack repair fabric that was placed and got shoved under the paving such that it caused the cracking observed. However please note this street had several large, difficult to control cracks, which can and will eventually reflect through the new overlay in the not too distant future. This work will probably be done in May or June. ICRD will follow-up with continued crack maintenance as will be necessary in the future to keep the street sealed.

There will be no further cost to the English Meadows paving project for the above repairs.
